Subject: Regarding free travel facility to girl students of the school/colleges/institutions in Haryana Roadways buses .

Reference on the subject noted above.

2. Sanction of the Governor of Haryana is hereby accorded for free travel facility to girl students of the Schools/Colleges/Institutions in Haryana Roadways buses as per following terms and conditions:-

- i The free passes will be issued to all girl students of the State studying in Schools/Colleges/Institutes situated in the State which are recognized by the State Govt./affiliated with any University or Board in the State.
The educational centers, coaching centers, study centers, distance learning centers and franchisees centers of Hartron and other centers which are affiliated with the universities of other State(s) and are not recognized by the Haryana Government will not be covered under this policy.
- ii The passes will be issued upto maximum limit of 60 Kms.
- iii The passes will be issued on the half yearly basis on the recommendation of the School/College/Institution authorities.
- iv The concerned School/College/Institutions will supply to the concerned depot of Haryana Roadways a list of the girl students alongwith an attested copy of the recognition/affiliation certificate issued by the competent authority.
- v The passes will be issued by the respective General Manager or an officer designated by him as per the list supplied by the School/College/Institution.
- vi The design/format of the pass will remain the same. However, the colour of the pass may be changed for easy recognition for which DST/DGST will issue necessary instructions to all the field offices separately.
- vii The respective GMs will keep/maintain proper record of the passes issued to the girl students so as to get the financial implications reimbursed from the concerned beneficiary department(s).
